



Data Express® DX115 SAS/SATA

Quick Start Guide

Features

- Rugged all-metal construction rated for up to 30,000 carrier insertions
- Flat front for seamless integration
- SAS frames are compatible with SATA drive carriers
- Cableless drive connection
- Soft start circuitry increases data integrity by eliminating in-rush current during spin-up



1. Installation Steps

1.1 Frame Installation

- a. Slide the DX115 frame into an open 5.25" drive bay on your computer.
- b. Secure the frame to the chassis with the mounting screws provided.
- c. Attach a SAS or SATA data cable to the data connector on the rear of the frame. Attach the other end to the appropriate SAS or SATA port on the computer.
- d. Attach a Molex power connector to the rear of the receiving frame.

1.2 Hard Drive Installation

- If the carrier is locked into the frame, insert a Data Express Key into the lock and turn it 90 degrees clockwise.
- b. Push in on the ejection handle of the carrier to pop it out. Use the handle to remove the carrier from the frame.
- c. Use a Phillips screwdriver to remove the two screws securing the carrier cover. The screws are located on either side of the front of the carrier.
- d. Remove the cover and attach a 3.5-inch or 2.5-inch drive to the unified power and data connector inside of the carrier.
- e. With one hand on the top of the drive, turn the carrier over. Then secure the drive to the carrier using the mounting screws provided.
- f. Reattach the carrier cover and secure it using the two screws you removed in Step C.

2 Operating Your DX115

2.1 Basic Operation

- a. Slide the DX115 carrier into the frame, then push the carrier handle in until it clicks.
- b. Insert the included Data Express Key into the keylock and turn it 90 degrees counterclockwise to secure the carrier to the frame.
- c. Press and hold the Power Button to power the unit on until the Drive Ready LED begins to flash and the hard drive inside begins to spin up.

Your DX115 is now ready to use! If the drive inside is already formatted, it can be used right away. If the drive is brand new or its format is not compatible with your computer, the drive will need to be formatted before being used.



Formatting a drive will erase all data on the drive, so be sure to back up your data before beginning this operation.



2.2 Safe Carrier Removal

Power off the unit by pressing the power button.



To prevent the possibility of losing data, ensure there are no file transfers in progress and the amber Drive Activity LED is off before turning off the DX115.

- Use the DataExpress Key to turn the keylock 90 degrees clockwise to unlock the unit.
- Push in on the ejection handle of the carrier to pop it out. Use the handle to remove the carrier from the frame.

3 Other Configuration Options

3.1 LED Activity

^{*}Some SATA PC systems/host controllers provide support for the Drive Activity LED feature (refer to the SATA PC system/host controller manufacturer's documentation for further information). The Drive Activity LED can be enabled via host connection (cable not included) to Pin 1 located on the receiving frame motherboard. Refer to the SATA PC system/host controller manufacturer's documentation for further information

3.2 Fan Error LED Disable Switch

This switch allows the user to disable the Fan Error LED. It is a pinhole located on the front of the DX115 frame just above the power button. Insert a paper clip or similar object to activate the switch. CRU® recommends replacing a faulty fan immediately. Contact Technical Support to obtain a new fan.

3.3 Jumper Chart

The following jumper chart indicates the functionality for each position on the jumper block located on the rear of the DX115.
